

MCGINNIS LAKE DISTRICT MEETING

May 29, 2021

TIME: 10:00 A.M. CALL TO ORDER

PLACE: NEW CHESTER TOWN HALL 629 MASON ST

COMMITTEE MEMBERS PRESENT: Barry Berndsen, Nancy Schmidt, Steve Zoulek and Jerry Poehler. Ken Robert was excused. 14 members were present.

The March 6, 2021 minutes were passed out at the meeting. A motion was made by Steve Zoulek to accept the minutes as written. Jerry Poehler seconded the motion. The motion passed.

Barry read the Treasurer's report. The beginning cash balance was \$26,578.43. Total Cash inflows was \$818.61. Cash outflows was \$47.00 Barry Berndsen (office supplies). \$37.58 David Rollmann, (Goose control Supplies), \$251.13 Cason & Associates (DNR Permit) \$22,490.00 Cason & Associates (Weed Treatment) \$37.58 Newspaper Announcement/ Affidavit) Total Cash outflows \$22,848.97. May 29 Cash Balance was \$4,548.07. Nancy Schmidt made a motion to accept the Treasurers report as read. Steve Zoulek seconded the motion. The motion passed.

Old Business

Goose Control Program.- PLEASE DO NOT FEED GEESE....We received permits from the DNR to work in 2 phases. The first to find the eggs and oil them so they do not mature. One nest was located and sprayed. This was the first year and a lot was learned regarding identification and treatment. We are now in the second phase where US Fish and Wildlife will send a team to perform a roundup. The cost of this will be \$3000.00. Land owners on the lake have been asked to sign permission slips to allow people to go on their land to help with the goose roundup. The board thanked Dave Rollmann

Lake Maintenance Activities - Dick Shuster reported after doing some research on curly leaf pond weed. By cutting the weeds we are spreading the curly leaf pond weed in the spring. A survey was done to see where the curly weed is and how it needs to be treated. We will be spraying the whole lake and not just parts. This will be done in 2 applications done the same day with different chemicals. This will also help remove dead vegetation. Some milfoil was located also and was treated to limit spread. Cason and Assoc. did the survey and the necessary treatments. The board thanked Dick for his assistance!!

New Business

Lake District individuals asked questions regarding Lake District activities but none needed to be acted on by the board at this time. We thanked attendees for their continued support and input!!!

A motion to adjourn was made by Steve Zoulek and seconded Nancy Schmidt
